Whereas, Sh. Suresh, TGT (NM) preferred CWP No. 2580/2024 titled as Suresh, TGT(NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GMS Kyarik, U/C GSSS Koti Dhiman, Distt. Sirmour, H.P. to nearby home station in Distt. Kangra, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 27-03-2024 when the Hon'ble High Court has passed the following orders:-

"4. Accordingly, the petition is disposed of by directing respondent No. 2, to consider and decide the representations of the petitioner, Annexure P-4, within a period of four weeks from today, by passing a detailed and reasoned order, strictly, in terms of the provisions of 'Comprehensive Guiding Principles-2013. Pending miscellaneous application(s), if any also stand disposed of."

In the compliance the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 23-04-2024. He attended the same and submitted his representation in this office, vide which he has requested that he has completed required tenure at his present place of posting i.e GMS Kyarik, U/C GSSS Koti Dhiman, Distt. Sirmour, H.P and he may be transferred to nearby home station in Distt. Kangra, H.P against vacancy/longer stayee by clubbing his/her previous stay.

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Kyarik, U/C GSSS Koti Dhiman, Distt. Sirmour, H.P w.e.f. 11-03-2021, and has completed the normal tenure of three years at present place of posting. Moreover, TGT (NM) is State Cadre post and the incumbents supposed to serve anywhere in the State as per requirement and administrative exigency. At present 32 students are studying in GMS Kyarik, U/C GSSS Koti Dhiman, Distt. Sirmour. If the petitioner will be transferred from there the studies of students will suffer adversely. Therefore, after critical examination and thoughtful application of mind the request made by the petitioner is hereby rejected on administrative ground and in larger public interest. The representation of the petitioner is disposed of accordingly.
