before the Hon'ble High Court, Shimla-2 on 07th May, 2024,when after hearing the
matter, the Hon'ble High Court has disposed of the same with the following directions/
order:-

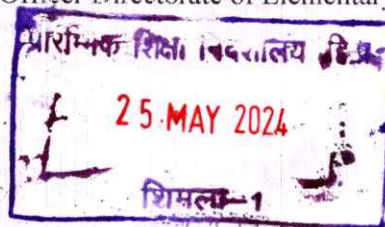
