The Petitioner, Smt. Minakshi Rana,TGT(Med), filed CWP No.4019/2024 titled as Minakshi Rana, Vs State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS Gehra Distt. Chamba (which falls under Hard/Tribal area) after the completion of required tenure as per policy. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 14th May,2024,when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

"Learned Counsel for the petitioner submits that interest of justice would be served,in case,the representation made by the petitioner(Annexure P-4 dated 21-11-2023) is directed to be decided by the competent Authority within in some reasonable time.

This writ petition is accordingly disposed of with the direction that the representation made by the the petitioner ,appended with the writ petition as Annexure P-4 dated 21-11-2023,shall be decided by the competent Authority ,in light of the averments made therein, within a period of four weeks from today.Pending miscellaneous application(s),if any also stand disposed of accordingly.

As per direction of the Hon'ble High Court the petitioner was called for personel hearing on dated 20th May,2024,but she could not attended the same. The petitioner has represented through her advocate to this office that she may kindly be adjusted at GSSS Banuri (Palampur) / GGSSS Palampur/GHS Pantehar u/c GSSS Rajpura/GSSS Ghar(Panchrukhi)/ GSSS Ghuggar/GSSS Averri/GSSS Bandala/GSSS Rapur(Palampur) Distt. Kangra against vacancy .

From the perusal of the record, it reveals that Smt. Minakshi Rana,TGT (Med), is presently working in GSSS Gehra Distt. Chamba (which falls under sub cadre area) since 13th May ,2021, has completed her normal tenure at present place of posting. At present there is no vacancy in above said insituations mentioned by the petitioner .Moreover,in GSSS Gehra Distt Chamba 208 students are studying from class VI to X.In the interest of the students post of TGT(Med) cannot be kept vacant.Therefore, keeping in view of the position stated above ,the representation made by the petitioner can not be acceded to and hereby rejected and disposed of accordingly.
