ORDER

In the matter of: "

CWP No. 7374/2023-titled as Kalpana Devi V/s State of Himachal Pradesh and others (Regarding Transfer).

Smt. Kalpana Devi, TGT (Arts) who is under order of transfer from GSSS, Balera Distt. (Sln.) to GSSS, Goela Distt. Solan has filed CWP No. 7374/2023-before the Hon'ble High Court of H.P., regarding seeking her adjustment at GSSS, Chandi District Solan. The case was Decided on 13.05.2024, when the same has been disposed of with the following orders:-

"Petitioner is permitted to withdraw the petition and to submit a representation to the competent authority i.e. respondent No.2 within two days from today. On receipt of such representation, respondent No.2 shall consider and decide the same within one week thereafter. Till final decision on the representation of the petitioner is not taken, the impugned transfer order shall not be implemented qua the petitioner. It is clarified that in case the petitioner does not submit his representation within two days, this order shall seize to have effect."

The petition is accordingly dismissed as withdrawn. Pending miscellaneous application(S), if any, shall also stand disposed of.

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Smt. Kalpana Devi, TGT (Arts) has submitted representation and requested that she may be adjusted at GSSS, Chandi Distt. solan against vacancy, on the ground of couple case as her husband is a Lecturer, Biology and working in GSSS, Chandi Distt. Solan.

From the perusal of record, it is revealed that Smt. Kalpana Devi, TGT (Arts) was transferred from GSSS, Balera District Solan to GSSS, Goela District Solan against vacancy, after completion of normal tenure with the approval of competent authority, where she was working since 07.03.2019. At present one posts of TGT (Arts) is lying vacant in GSSS, Chandi Distt. solan. Keeping in view the position stated above, representation of petitioner i.e Smt. Kalpana Devi, TGT (Arts) is considered sympathetically and she is hereby adjusted at GSSS, Chandi Distt. Solan against vacancy, without TTA/JT. The representation of the petitioner is disposed of accordingly.
