In the matter of: CWP No. 4437/2024 -titled Balbir Singh Vs. State of H.P. & Others.

Whereas, Sh. Balbir Singh, TGT (NM) preferred CWP No. 4437/2024 titled as Balbir Singh, TGT (NM) Vs. State of H.P. aggrieved of his transfer from GSSS Bharmar, Distt. Kangra to GHS Kiyao (15/20), Distt. Shimla, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 22.05.2024, when the Hon'ble High Court has passed the following orders:-

" In view of the above submissions, this writ petition is disposed of with a direction to respondent No.2/comptent authority to consider and decide the aforesaid representation of the petitioner dated 17.05.2024 (Annexure P-5)in accordance with law and applicable policy within a week from today. The decision so arrived at shall also be communicated to the petitioners."

The writ petition stand disposed of in the above terms, so also the pending miscellaneous application(s), if any."

As per diction of the Hon'ble High Court the petitioner submitted his representation to the undersigned, in which he has requested that he may be adjusted in GSSS Chowari Distt Chamba against vacancy. The petitioner has further stated that his wife is also Govt employee and is serving as Centre Head Teacher in GPS Bharmar, Distt Kangra & due to his adverse family circumstances he may be posted closer to his home..

The representation has been examined carefully and it is revealed that the petitioner has been transferred from GSSS Bharmar Distt Kangra to GHS Kiyao (15/20) Distt Shimla (in view of CWP No 3030/2024 (by clubbing of previous stay). I find it appropriate to adjust the petitioner in GSSS Chowari Distt Chamba against vacancy. With these observations the representation of the petitioner is considered and disposed of accordingly.

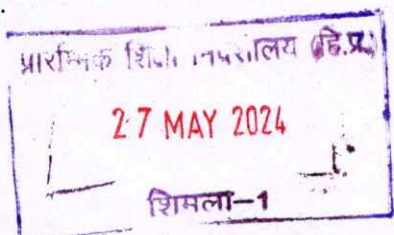
