In the matter of: CWP No. 3830/2024 -titled as Ajay Kumar Vs. State of H.P. & Others.

Whereas, Sh. Ajay Kumar, TGT (NM) preferred CWP No. 3830/2024 titled as Ajay Kumar, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P aggrieved his transfer from GSSS New Kangra, Distt. Kangra to GSSS Dharogra, Distt. Shimla, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 07.05.2024, when the Hon'ble High Court has passed the following orders:-

"Larned consel for the petitioner has submitted that the petitioner's mother is suffering from ailment and as such he is not in a position to join at the place where he has been transferred. Petitoner has already compledted his normal tenure at Government Senior Secondary School New Kangra, District Kangra, H.P and as regards ailment of his mother, he is at liberty to approach his employer. No orders are required to be passed by this Court in the instant petition.

On the facts as discussed above, though the impugned order is not interfered with, however, it is made clear that the petitioner shall not be relieved till the lifting of model code of conduct on an earlier date without the concurrence of the Election Commission.

The petition stand disposed of. Pending application, if any, also stand disposed of."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 20-05-2024. He attended the same and submitted his representation in this office, vide which he has requested that he may be transferred/adjusted at GMSSS Chauri Khas/ GHS Mankot/GMS Kandei u/c GSSS Chuhan/GMSSS Kakela u/c GSSS Kohlari, Distt. Chamba, against vacancy. He has further stated that his mother is suffering from various ailments. As such there is no one in the family to look after old ailing mother.

Whereas, from perusal of record, it has been found that the petitioner is working at GSSS New Kangra, Distt. Kangra and under order of transfer to GSSS Dharogra, Distt. Shimla. (in view of CWP No 3830/2024 (by clubbing of previous stay). At present the post of TGT (NM) is lying vacant at GHS Mankot, Distt. Chamba, H.P. The petitioner has given willingness for his transferred/adjustment to the aforesaid school against vacancy. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred/adjusted at GHS Mankot, Distt. Chamba, H.P. against vacancy, without TTA/JT. The representation of the petitioner is disposed of accordingly.
