Surender Pal Sharma, TGT (Arts) vice versa by clubbing his previous stay, regarding seeking his adjustment at GHS, Jubhakhar u/c GSSS, Nand District Solan. 
"In view of the above submissions, this writ petition is disposed of by granting liberty to the petitioner to represent to respondent No.2/competent authority for his suitable adjustment within a week from today. In case such a representation is made, respondent No.2 / competent authority shall consider and decide the same in accordance with law and applicable transfer policy, within a period of two weeks thereafter. The decision so arrived at shall also be communicated to the petitioner."

Interim order dated 22.03.2024, as extended from time to time, is vacated forthwith. It shall, however, be open for the petitioner to avail leave of the kind due till the decision of the representation.

The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(S), if any.

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Sh. Satish Kumar, TGT (Arts) has submitted representation and requested that he may be adjusted at GHS, Jubhakar Distt. Solan against vacancy, on the ground of medical condition as he is a heart patient and gone a balloon angioplasty took place in the year of 2016 and still there is 40% blockage in one of his artery.

Keeping in view the position stated above, representation of petitioner i.e Sh. Satish Kumar, TGT (Arts) is considered sympathetically and he is hereby adjusted at GHS, Jubhakar Distt. Solan against vacancy, without TTA/JT. The representation of the petitioner is disposed of accordingly.
