Whereas, Sh. Bharat Bhushan, TGT (NM) preferred CWP No. 4397/2024 titled as Bharat Bhushan Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Bharara, Distt. Chamba to the station nearby his native place in Distt. Kangra, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 21-05-2024 when the Hon'ble High Court has passed the following orders:-

"In view of the above the impugned order dated 07.05.2024 (Annexure P-4), turning down petitioner's representation, is quashed and set aside. Respondent No.2 is directed to decide the case of the petitioner for his transfer/adjustment afresh in accordance with law and applicable policy within a period of two-week from today. The decision so arrived at shall also be communicated to the petitioners:"

The writ petition stand disposed of in the above terms, so also the pending miscellaneous application(s), if any."



Whereas, Sh. Bal Krishan, TGT (NM) preferred CWP No. 3550/2024 titled as Bal Krishan, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P aggrieved his transfer from GHS Bandal, Distt. Kangra to GSSS Rathal, Distt. Shimla, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 30.04.2024, when the Hon'ble High Court has passed the following orders:-

"Learned counsel for the petitioner has submitted that the petitioner is suffering from ailment and as such he is not in a position to join at the place where he has been transferred. Petitioner has already completed his normal tenure at GHS Bandal, District Kangra, H.P and as regards his ailment, he is at liberty to approach his employer. No orders are required to be passed by this Court in the instant petition.

On the facts as discussed above, though the impugned order is not interfered with, however, it is made clear that the petitioner shall not be relieved till the lifting of model code of conduct on an earlier date without the concurrence of the Election Commission.

The petition stand disposed of. Pending application, if any, also stand disposed of."

In above matter the petitioner representation received in this office dated 05.05.2024 in his representation the petitioner has stated that he is suffering from ailment and is not in a position to join at the place where he has been transferred. So he has requested to adjust him in GMS Kandei, u/c GSSS Chuhan, Distt. Chamba against vacancy.

Whereas, from perusal of record, it has been found that the petitioner is working at GHS Bandal, Distt. Kangra and under order of
