Whereas, Sh. Ajay Singh Rana, TGT (NM) preferred CWP No. 4405/2024 titled as Ajay Singh Rana Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Rajiana Bandh, Distt. Kangra to GMS Charew u/c GSSS Kaffota, Distt. Sirmour. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 21.05.2024, when the Hon'ble High Court has passed the following orders:-

"The praye is not opposed by the counsel on the other side. Hence, this writ petition is disposed of with direction that the impugned transfer order dated 16.05.2024 to the extent if effects the transfer of respondent No. 5 shall come into force after Mode Code of Conduct ceases to be in force. The petitioner is permitted to represent to the respondents seeking his adjustment within a period of five days, whereafter, respondent No. 2 is directed to consider and decide the representation of the petitioner within a further period of one week. Dicision so arrived at by the respondents shall be communicated to the petitioner.

Pending miscellaneous applications, if any, also stand disposed of."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner has submitted his representation in this office vide which he has requested that he may be transfer/adjusted at GMS Jagni u/c GSSS Jassai, Distt. Kangra, H.P against vacancy or against longer stayee by clubbing their previous stay due to adverse family circumstances.

Whereas, from perusal of record, it has been found that the petitioner is working at GSSS Rajiana Bandh, Distt. Kangra, and under orders of transfer to GMS Charew u/c GSSS Kaffota, Distt. Sirmour, H.P. One Sh. Ajay Kumar, TGT(NM) is working in GMS Jagni U/c GSSS Jassai, Distt. Kangra, H.P since 19.04.2021. The petitioner has given willingness for his transfer/adjustment to the aforesaid school against longer stayee by clubbing his previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred/adjusted without TTA from GMS Charew u/c GSSS Kaffota, Distt. Sirmour to GMS Jagni U/c GSSS Jassai, Distt. Kangra, H.P. vice Sh. Ajay Kumar TGT(NM), against longer stayee by clubbing his previous stay within radius of 30 Kms., with TTA/JT to Sh. Ajay Kumar, TGT(NM). The representation of the petitioner is disposed of accordingly.
