Whereas, Sh. Rajeshwar Kandoria, TGT (NM) who is u/t from GMS Talara u/c GSSS Ganoh, Distt. Kangra to GSSS Guwan, Distt. Chamba has filed CWP No. 3240/2024 titled as Rajeshwar Kandoria, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer/adjustment in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 22.04.2024, when after hearing the matter the Hon'ble High Court has directed as under:-

"1. Learned counsel for the petitioner seeks permission to withdraw the instant petition with liberty to submit his representation to the competent authority.

Prayer being innocuous is allowed.

Petitioner is permitted to withdraw the instant petition with liberty as

prayed.

Pending miscellaneous application(s), if any shall also stand disposed

of."

In compliance to the directions of the Hon'ble High Court the petitioner attended personal hearing on 20.05.2024. The petitioner requested that he may kindly be adjusted in Distt. Kangra against vacancy/longer stayee within the radius of 30 Kms.

On the perusal of relevant records, it reveals that Sh. Rajeshwar Kandoria, TGT (NM) was transferred from GMS Talara u/c GSSS Ganoh, Distt. Kangra to GSSS Guwan, Distt. Chamba vice Naresh Kumar TGT (NM) vide this Directorate order dated, 18.04.2024 after completion of his normal tenure within the radius of 30 Kms. The petitioner Sh. Rajeshwar Kandoria, TGT (NM) has already joined at transferred station i.e. GSSS Guwan, Distt. Chamba on dated, 29.04.2024 and having very short stay at present place of posting.

Therefore, keeping in view the position stated above, representation made by Sh. Rajeshwar Kandoria, TGT (NM) is not tenable and the same is hereby rejected. Representation of the petitioner is disposed of accordingly.



Whereas, Sh. Rakesh Kumar Sethi, TGT (NM) GSSS Garsa, Distt. Kullu has filed CWP No. 3367/2024-titled as Rakesh Kumar Sethi, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding transfer from GSSS Garsa, Distt. Kullu to Distt. Mandi/Bilaspur, against vacancy/ longer stayee. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 25.04.2024 when the Hon'ble High Court has passed the following orders:-

"5. Accordingly, this writ petition is disposed of with the direction that let representation (Annexure P-1) be decided within a period of six weeks from today and taking into consideration the fact that the petitioner is serving at the present station for the last five years, if possible, he be adjusted at either one of the stations mentioned in the representation or any other stations which may be convenient to the petitioner. Pending miscellaneous applications, if any, also stand disposed of."

In compliance to the directions of the Hon'ble High Court the petitioner has attended personal hearing on 20.05.2024 and submitted his representation wherein he has requested that he may kindly be adjusted in Distt. Mandi/Bilaspur, against vacancy or longer stayee by clubbing previous stay within the radius of 30 Kms.

On the perusal of the record, it reveals that Sh. Rakesh Kumar Sethi, TGT (NM) is working in GSSS Garsa, Distt. Kullu since July, 2021 and having short stay at his present place of posting as he has not completed three years of stay as per policy framed by the Government.

Therefore, keeping in view the position stated above, request made by Sh. Rakesh Kumar Sethi, TGT (NM) on 20.05.2024 cannot be considered at this stage and the same is hereby rejected. The representation of the petitioner is disposed of accordingly.


