The Petitioner, Ku. Urmila,TGT (Med),filed CWP No. 7260/2024 titled as, Kumari Urmila , TGT,(Med) Vs State of H.P. before the Hon'ble High Court of H.P. aggrieved her transfer from GSSS Jaihahr (Pachhad) Distt.Sirmour to GSSS Kanger Dharyar Distt. Sirmour. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 24<sup>th</sup> May.2024, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

(i) *"The petitioner is permitted to make a representation to respondent No.2/ competent authority seeking her adjustment in light of her adverse family circum stances within a period of two weeks.*

(ii) *Respondent No.2 competent authority shall sympathetically consider the representation of the petitioner and decide the same in accordance with law and applicable transfer policy within a period of two weeks thereafter.*

(iii) *The decision ,so taken ,shall be communicated to the petitioner .*

*Till the decision,operation of the impugned order shall remain stayed."*

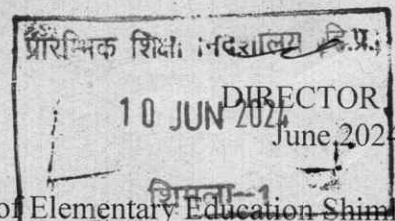
As per direction of the Hon'ble High Court the petitioner was called for personel hearing on dated 06<sup>th</sup> May,2024, The petitioner attended the personal hearing on scheduled date and time. During personal hearing she has requested that she may be adjusted at GHS Swahal u/c GSSS Bohni/GSSS Kot GHS Sasan Distt Hamirpur against longer stay by clubbing previous stay. The petitioner has further stated that she is facing some difficulties at the domestic front, and hence, she may be posted closer to ~~his~~ home.

From the perusal of the record, it reveals that Ku. Urmila TGT (Med) is presently u/t from GSSS Jaihahr (Pachhad) Distt.Sirmour to GSSS Kanger Dharyar Distt. Sirmour, with the prior approval of the competent authority. As per averments made by the petitioner,the representation is considered sympathically and she is hereby adjusted in GSSS Kot Distt Hamirpur vice Smt. Rajni Kumari ,TGT (Med) (by clubbing her previous stay),with TTA/JT.With these observations the representation of the petitioner is considered and disposed of accordingly.

The Petitioner, Sh. Kulvinder Kumar, TGT(Med), filed CWP No. 4435 /2024 titled as Kulvinder Kumar, Vs State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Devikothi Distt. Chamba (which falls under Hard/Tribal area) after the completion of required tenure as per policy. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 22<sup>nd</sup> May, 2024, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

*"In view of the above submission, this writ petition is disposed of by permitting the petitioner to make a fresh representation to respondent No.2 within a week from today, indicating the stations where the vacancie are available ffor his adjustment, which shall be considered and decided by respondent No.2/ competent authority in accordance with law and applicable policy, within a period of two weeks thereafter. The decision so arrieved at shall also communicated to the petitioner*

*The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any."*

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 06<sup>th</sup> May, 2024, The petitioner attended the personal hearing on scheduled date and time. During personal hearing he has requested that he may be adjusted at GHS Bari /GSSS Moonndhi/GHS Manjha/GSSS Kacchair Distt. Kangra and GSSS Chabutra Distt. Hamirpur against longer stay by clubbing previous stay.

From the perusal of the record, it reveals that Sh. Kulvinder Kumar, TGT (Med), is presently working in GSSS Devikothi Distt. Chamba (which falls under Hard/Tribal area) since 24<sup>th</sup> Feburary, 2021, has completed his normal tenure at present place of posting. I find it appropriate to transfer the petitioner to GHS Bari Distt. Kangra vice Smt. Reena Sharma, TGT (Med), (by clubbing her previous stay) with TTA/JT. With these observations the representation of the petitioner is considered and disposed of accordingly.
