(in view of CWP.No.3330/2024 titled as Smt. Jeevan Jyoti,TGT Medical, by clubbing of previous stay). As per averments made by the petitioner his wife is also government employee and posted in Matton Sidh Distt. Hamirpur and being a couple case, he may be transferred/adjusted in GHS Dhamrol Distt. Hamirpur vice Sh. Surinder Singh ,TGT(Med) (by clubbing his previous stay) with TTA/JT. With these observations the representation of the petitioner is considered and disposed of accordingly
