ORDER.

In the matter :CWP No.4878/2024 titled as Smt. Meena Kumari,TGT(Med) VS State of H.P. & others.

The Petitioner, Smt. Meena Kumari, TGT (Med)) filed CWP No. 4878/2024 titled as, Smt. Meena Kumari, TGT (Med) Vs State of H.P. before the Hon'ble High Court of H.P. against her transfer from GSSS Rajiana (53 mile) Distt. Kangra to GHS Tippri u/c GSSS Bathu TippriDistt. Kangra .The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 30<sup>th</sup> May.2024, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/order:-

Kangra vice Smt.Rakhee Sharma ,TGT(Med) with TTA/JT(by clubbing her previous stay). With these observations the representation of the petitioner is considered and disposed of accordingly.

With these observations the representation of the petit oner is considered and disposed of accordingly.




