In the matter of: CWP No. 4709/2024 titled as Brij Pankaj Dixit, TGT (NM) Vs. State of H.P & ors.

Whereas, Sh. Brij Pankaj Dixit, TGT (NM) who is u/t from GMS Karahpura u/c GSSS Dhaloon, Distt. Kangra to GMS Dhabrain u/c GSSS Sach, Distt. Chamba has filed CWP No. 4709/2024 titled as Brij Pankaj Dixit, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer/adjustment in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court Himachal Pradesh on 27.05.2024 when the Hon'ble High Court has passed the following orders:-

"6. In view of the above submissions, this writ petition is disposed of by permitting the petitioner to make a representation to respondent No. 2 within two weeks from today which shall be considered and decided by respondent No. 2/competent authority in accordance with law and applicable policy, within a period of two weeks thereafter. The decision so arrived at shall also be communicated to the petitioner.

The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any."

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 06.06.2024. He has attended the same and submitted his representation in this office on 06.06.2024 vide which he has requested that he has completed normal tenure at his present place of posting i.e GMS Karahpura u/c GSSS Dhaloon, Distt. Kangra, H.P and he further requested that he may be transferred/adjusted at DIET Dharamshala/GSSS Jadrangal and GSSS Tang Narwana in Distt. Kangra, against vacancy/ longer stayee by clubbing his/her previous stay.

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Karahpura u/c GSSS Dhaloon, Distt. Kangra w.e.f. 28.06.2021 and has completed three years stay (by Clubbing) at present place of posting. One Sh. Sapandeep Sanghera TGT (NM) is working in GSSS Jadrangal, Distt. Kangra since 18.04.2023. The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing his previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred/adjusted without TTA from GMS Dhabrain u/c GSSS Sach, Distt. Chamba to GSSS Jadrangal, Distt. Kangra, vice Sh. Sapandeep Sanghera, TGT (NM) against longer stay by clubbing his previous stay within radius of 30 Kms. with TTA/JT to Sh. Sapandeep Sanghera, TGT (NM). The representation of the petitioner is disposed of accordingly.
