## **ORDER**

In the matter of:

CWP No. 3382/2024-titled as Anil Kumar V/s State of Himachal Pradesh and others (Regarding Transfer).

Sh. Anil Kumar, TGT (Arts) has filed CWP No. 3382/2024 titled as Anil Kumar V/s State of H.P. in the Hon'ble High Court, and seeking his transfer from GSSS, Bajrolipul Distt. Shimla to GSSS, Galliyan, CSSS, Kapahara, GHS Samlohal u/c GSSS, Kapahara, GHS Gahar u/c GSSS, Dadhol Distt. Bilaspur. The case was listed before the Hon'ble High Court of H.P. on 26.04.2024, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"Accordingly, the petition is disposed of with direction to respondent No.2 to consider and decide the representation of the petitioner within four weeks from the date of production of a copy of this order."

Pending miscellaneous applications, if any, shall also stand disposed

of.

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Sh. Anil Kumar, TGT (Arts) has attended the personal hearing on 13.06.2024 and stated that he has completed normal tenure at his present place of posting i.e GSSS, Bajrolipul Distt. Shimla which is 200 Km. away from his home and facing many domestic problems.

From the perusal of record, it is found that Sh. Anil Kumar, TGT (Arts) is working at GSSS, Bajrolipul Distt. Shimla since 15.01.2019 and has completed normal tenure at his present place of posting. At present the posts of TGT (Arts) are not lying vacant in the above mentioned school. Moreover, one post of TGT (Arts) is lying vacant in GHS, Mandyali u/c GSSS, Toba District Bilaspur and 116 student are enrolled in the said school.

Keeping in view the position stated above, representation of the petitioner i.e Sh. Anil Kumar, TGT (Arts) is considered sympathetically and he is hereby transferred from GSSS, Bajrolipul Distt. Shimla to GHS, Mandyali u/c GSSS, Toba Distt. (Bilaspur) against vacancy, without TTA/JT in the welfare of students studying there. The representation of the petitioner is disposed of accordingly.
