ORDER

In the matter of:

CWP No. 4786/2024-titled as Anjana Kumari, TGT (Arts) V/s State of Himachal Pradesh (Regarding Transfer).

Smt. Anjana Kumari, TGT (Arts) has filed CWP No. 4786/2024 titled as Anjana Kumari V/s State of H.P., and seeking her transfer from GMS Saranal u/c GSSS Thalout (MND) either to GHS Gatti u/c GSSS Bagla or GHS Mandal u/c GBSSS Bhangrotu or GSSS Lohara, District Mandi against longer stayee by clubbing their previous stay. The Operative portion of the present CWP judgment is as under:-

"In view of the above submissions, this writ petition is disposed of by directing respondent No. 2/competent authority to consider and decide the aforesaid representation of the petitioner (annexure P-2) in accordance with law and applicable policy, within a period of four weeks from today. The decision so arrived at shall also be communicated to the petitioner. The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any."

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Smt. Anjana Kumari, TGT (Arts) has submitted fresh representation and sought her transfer from GMS Saranal u/c GSSS Thalout (MND) either to GHS Gatti u/c GSSS Bagla, GHS Mandal u/c GBSSS Bhangrotu or GSSS Lohara, District Mandi against longer stayee by clubbing their previous stay due to her adverse family circumstances.

From the perusal of record, it is revealed that Smt. Anjana Kumari, TGT (Arts) is working at GMS Saranal u/c GSSS Thalout, District Mandi since 21-01-2019 and has completed normal tenure at her present place of posting. At present post of TGT (Arts) are not lying vacant in the above mentioned schools, however one Sh. Rajender Kumar, TGT (Arts) is working in GMS Ghatti u/c GSSS Thalout District Mandi since 05-09-2023 and having short stay, but serving within the radius of 10 kilometers last 03 years. The continuous services rendered by employees of Education Department within a radius of 30 Kms. be considered stay/tenure at one station & such services will be clubbed for calculation of tenure purpose of transfers.

Keeping in view the position stated above, representation of petitioner Smt. Anjana Kumari, TGT (Arts) is considered sympathetically and she is hereby transferred from GMS Saranal u/c GSSS Thalout, District Mandi to GHS Ghatti u/c GSSS Bagla, District Mandi vice Sh. Rajender Kumar, TGT (Arts) and vice versa by clubbing his previous place of postings tenure (with TTA/JT to Sh. Rajender Kumar). Therefore, representation of the petitioner with the present CWP is disposed of according प्रारमिक शिद्धा नियनाराय
