In the matter of: CWP No. 9141/2023 -titled as Ramesh Kumar Vs. State of H.P. & Others.

Whereas, Sh. Ramesh Kumar, TGT (NM) preferred CWP No. 9141/2023 titled as Ramesh Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Mundroo, Distt. Mandi, H.P to GSSS Sudhrani, Distt. Mandi, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 22-04-2024 when the Hon'ble High Court has passed the following orders:-

"2. At this stage, learned counsel for the petitioner submits that the petitioner be at least granted liberty to file representation for his adjustment to some other station, if possible. It is clarified that withdrawal of the petition shall not come in the way of the petitioner in making an appropriate representation for his adjustment at some other station. Pending miscellaneous application(s), if any, also stand disposed of accordingly."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 07-06-2024. He attended the same and submitted his representation in this office, vide which he has requested that he may be transferred/ adjusted at nearby home station in Distt. Mandi, H.P against vacancy/ longer stayee by clubbing his/her previous stay.

From perusal of record, it has been found that the petitioner has been working at GSSS Mundroo, Distt. Mandi, H.P. w.e.f 06-10-2023 and under transfer to GSSS Sudhrani, Distt. Mandi, H.P. Moreover, TGT(NM) is State Cadre post and the incumbents supposed to serve anywhere in the State as per requirement and administrative exigency. The petitioner Sh. Ramesh Kumar, TGT(NM) has already joined at GSSS Sudhrani, Distt. Mandi on dated 10-01-2024. Therefore, after critical examination and thoughtful application of mind the request made by the petitioner is hereby rejected on administrative ground and in larger public interest. The representation of the petitioner is disposed of accordingly:

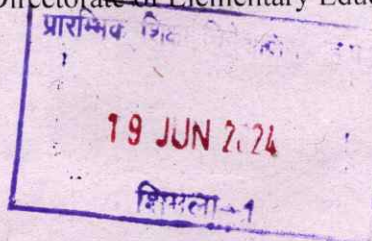
