Whereas, Sh. Suresh Kumar, TGT (NM) who is u/t from GHS Jhor, u/c GSSS Kapahi, Distt. Mandi to GMS Koon, u/c GSSS Balag, Distt. Mandi has filed CWP No. 3195/2024 titled as Suresh Kumar, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer/adjustment in nearby his native place Distt. Mandi. The above writ petition was listed before the Hon'ble High Court Himachal Pradesh on 22.04.2024 when the Hon'ble High Court has passed the following orders:-

"Learned Counsel for the petitioner after making submission for sometime prays for and is permitted to withdraw the petition. At this stage, learned Counsel for the petitioner submits that the petitioner be further granted liberty to make a representation for his posting at some other station. The only observation that this Court can make is that this Court has not stalled the petitioner from making any such representation, if he so advised."

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 07.06.2024. He has attended the same and submitted his representation in this office on 07.06.2024 vide which he has requested that he has completed normal tenure at his present place of posting i.e GHS Jhor u/c GSSS Kapahi, Distt. Mandi, H.P and he further requested that he may be transferred/adjusted in Distt. Mandi, against vacancy/ longer stayee by clubbing his/her previous stay.

Whereas, from perusal of record, it has been found that the petitioner is working at GHS Jhor u/c GSSS Kapahi, Distt. Mandi w.e.f. 29.09.2022 and has completed three years stay (By clubbing) at present place of posting. One Sh. Raj Kumar TGT (NM) is working in GSSS Sadhot, Distt. Mandi since 20.09.2022. The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing his previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred/adjusted without TTA from GMS Koon u/c GSSS Balag, Distt. Mandi to GSSS Sadhot, Distt. Mandi, vice Sh. Raj Kumar Bhardwaj, TGT (NM) against longer stay by clubbing his previous stay within radius of 30 Kms. with TTA/JT to Sh. Raj Kumar Bhardwaj, TGT (NM). The representation of the petitioner is disposed of accordingly.
