Whereas, Sh. Surinder Kumar, TGT (NM) preferred CWP No. 6071/2023 titled as Surinder Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Lakhnoo, Distt. Bilaspur, H.P to GHS Majhagan, Distt. Mandi, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 17-05-2024 when the Hon'ble High Court has passed the following orders:-

*"2. Petition is disposed of by granting liberty, as prayed for. In the event of any such representation being filed by the petitioner within a period of one week, the same be decided by the competent authority within a period of two weeks as from the receipt thereof. Till then interim to continue. Pending miscellaneous application(s), if any, stand disposed of."*

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 14-06-2024. He attended the same and submitted his representation in this office on 14-06-2024, vide which he has requested that he may be transferred/ adjusted at nearby in Distt. Solan, H.P against vacancy/ longer stayee by clubbing his/her previous stay.

From perusal of record, it has been found that the petitioner has been working at GSSS Lakhnoo, Distt. Bilaspur, H.P. w.e.f 01-09-2008 and has completed more then (15) years stay at present place of posting and under transfer to GSSS Majhagan, Distt. Mandi, H.P. Moreover, TGT(NM) is State Cadre post and the incumbents supposed to serve anywhere in the State as per requirement and administrative exigency. Therefore, after critical examination and thoughtful application of mind the request made by the petitioner is hereby rejected on administrative ground and in larger public interest. The petitioner is hereby directed to join at GHS Majhagan, Distt. Mandi, H.P. The representation of the petitioner is disposed of accordingly.

**ORDER**

In the matter of: CWP No. 5035/2024 titled as Kuldeep Singh Vs. State of H.P. & Others.

Whereas, Sh. Kuldeep Singh, TGT (NM) preferred CWP No. 5035/2024 titled as Kuldeep Singh Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Kohlari, Distt. Chamba to nearby his native place of Distt. Kangra against vacancy/longer stayee by clubbing his/her previous stay. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 31.05.2024 when the Hon'ble High Court has passed the following orders:-

*"4. In view of the above submission, this writ petition is disposed of by permitting the petitioner to make a fresh representation to respondent No. 2, seeking his transfer, within a week from today, which shall be considered and decided by respondent No. 2/competent authority in accordance with law and applicable policy, within a period of three weeks thereafter. The decision so arrived at shall also be communicated to the petitioner.*

*The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any."*

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 15.06.2024. He has attended the same and submitted his representation in this office on 15.06.2024 vide which he has requested that he has completed normal tenure at his present place of posting i.e GSSS Kohlari, Distt. Chamba, H.P and he has requested to adjust him at GHS Jalari, Distt. Kangra, against vacancy being caused due to retirement of present incumbent on 30.09.2024.

From perusal of record, it has been found that the petitioner has been working at GSSS Kohlari, Distt. Chamba 11.03.2019 and has completed more than five years stay there. One post of TGT (NM) is likely to be caused vacant in GHS Jalari District Kangra due to retirement of present incumbent on 30.09.2024. Keeping in view, the above facts and circumstances, the case of the petitioner for transfer is considered sympathetically and he is hereby transferred without TTA/JT from GSSS Kohlari, Distt. Chamba to GHS Jalari District Kangra, against vacancy being caused ~~vacant~~ due to retirement of present incumbent on 30.09.2024. These orders will be implemented after 30.09.2024. The representation of the petitioner is disposed of accordingly.
