ORDER.

In the matter :CWP No.2734/2024 titled as Smt. Monika Katna, TGT(Med) VS State of H.P. & others.

The Petitioner, Smt. Monika Katna, TGT (Med)) filed CWP No. 2734/2024 titled as, Smt. Monika Katna, TGT (Med) Vs State of H.P. before the Hon'ble High Court of H.P. aggrieved her transfer from GHS Khianpatt Distt. Kangra to GSSS Chobia (Bharamour) Distt. Chamba. With these observations the representation of the petitioner is considered and disposed of accordingly.
