Whereas, Sh. Suresh, TGT (NM) preferred CWP No. 4797/2024 titled as Suresh Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Kyarik u/c GSSS Koti Dhiman, District Sirmour to the station nearby his native place in Distt. Kangra, against vacancy/ longer stayee by clubbing his/her previous stay. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 28.05.2024 when the

Hon'ble High Court has passed the following orders:-

"In view of the above, this writ petition is allowed. Impugned order dated 22.05.2024 is quashed and set aside. The petitioner is at liberty to file fresh representation to respondent No. 2, seeking transfer from his present place of posting to a station of his choice, within a period of two weeks from today, whereafter the same shall be considered and decided by respondent No. 2/competent authority in accordance with law and applicable transfer policy, within a period of two weeks thereafter. The decision so arrived at shall also be communicated to the petitioner.

The writ petition stands disposed of in the above terms, so also the pending

miscellaneous application(s), if any."

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 14.06.2024. He has attended the same and submitted his representation in this office on 14.06.2024 vide which he has requested that he has completed normal tenure at his present place of posting i.e GMS Kyarik u/c GSSS Koti Dhiman, Distt. Sirmour, H.P and he further requested that he may be transferred/adjusted in Distt. Kangra, against vacancy/ longer stayee by clubbing his/her previous stay.

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Kyarik u/c GSSS Koti Dhiman, Distt. Sirmour w.e.f. 23.02.2021 and has completed three years stay at present place of posting. One Sh. Ajeet Kumar TGT (NM) is working in GMS Diara u/c GSSS Gharoh, Distt. Kangra since 25.04.2022. The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing his previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred/adjusted without TTA from GMS Kyarik u/c GSSS Koti Dhiman, Distt. Sirmour to GMS Diara u/c GSSS Gharoh, Distt. Kangra, vice Sh. Ajeet Kumar, TGT (NM) against longer stay by clubbing his previous stay within radius of 30 Kms. with TTA/JT to Sh. Ajeet Kumar, TGT (NM). The representation of the petitioner is disposed of accordingly.
