**ORDER**

In the matter of: CWP No. 2544/2024-titled as Mahender Kumar, TGT (Arts) V/s State of Himachal Pradesh (Regarding Transfer).

Sh. Mahender Kumar, TGT (Arts) has filed CWP No. 2544/2024 titled as Mahender Kumar V/s State of H.P., and seeking his transfer from GSSS Dhulhara (KGR) to soft area of his choice. The case was listed before the Hon'ble High Court of H.P. on 26-03-2024, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgment is as under:-

*“Learned counsel for the petitioner seeks permission to of this court to withdraw the present petition with liberty to pursue his representation with the competent authority, which he has already submitted.*

*Prayer being innocuous is allowed. Accordingly, the present petition is dismissed as withdrawn with liberty as aforesaid. Pending miscellaneous applications, if any also stand disposed of.”*

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Sh. Mahender Kumar, TGT (Arts) has attended the personal hearing on 19-07-2024 and has submitted representation, wherein request to transfer from GSSS Dhulhara, District Chamba either to GSSS Khaniara/GSSS Rajal/GSSS Baroh, District Kangra, against vacancy being caused due to retirement of present incumbents on 31-07-2024, in view of his domestic problems.

From the perusal of record, it is revealed that Sh. Mahender Kumar, TGT (Arts) is working at GSSS Dhulhara, District Chamba since 18-12-2020 and has completed normal tenure at present place of posting. One post of TGT (Arts) is going to vacant at GSSS Rajal (KGR), due to retirement of present incumbent on 31-07-2024, wherein 121 students are studying.

Keeping in view the position stated above, representation of the petitioner i.e Sh. Mahender Kumar, TGT (Arts) is considered sympathetically and petitioner is hereby transferred from GSSS Dhulhara, Chamba to GSSS Rajal, District Kangra, against vacancy, being caused due to retirement of present incumbent on 31.07.2024, without TTA/JT. The petitioner will join after superannuation of present incumbent i.e. after 31.07.2024. Therefore, representation of the petitioner with the present CWP is disposed of accordingly.
