Whereas, Sh. Narender Pal, TGT (NM) preferred CWP No. 5828/2024titled as Narender Kumar Vs. State of H.P. in the Hon'ble High Court of H.P. against this office order dated 18.6.2024 and seeking the relief to the extent that the petitioner may be transferred from GMS Lassi u/c GSSS Chattri, Distt. Mandi to nearby home station in Distt Mandi. against vacancy/ longer stayee. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 18-11-2024 when the Hon'ble High Court has passed the following order

"From the perusal of the impugned order dated 18.06.24 (Annexure P-6) it transpires that the respondents have not considered the transfer case of the petitioner from Government Middle School Lassi only on the ground that he is the only TGT working there and in case he is transferred from the aforesaid school, studies of students will suffer adversely. The respondents have failed to justify the necessity for continued posting of petitioner in the aforesaid school w.e.f. 11.11.2019 and as to why some other TGT teacher cannot be posted in the aforesaid school."

That the record of the instant case revealed that Sh. Narender Pal TGT (NM) is working at GMS Lassi u/c GSSS Chattri, (Subcadre) Distt Mandi. Since 11.11.2019 and has completed more than 05 years at his present place of posting and one Smt. Kaushalya Devi, TGT (NM) working at GSSS Galma Distt. Mandi is serving within the radius of 30 Kms. since, 2016.

Keeping in view the above narrated position, petitioner i.e Sh. Narender Pal, TGT (NM) is hereby transferred to GSSS Galma vice Smt. Kaushalya Devi, TGT (NM) (with TTA/JT) by clubbing her previous station. The above CWP is disposed of accordingly.
