Functions

- 3 To scrutinize charge sheets (challans) in criminal cases before their final submission in the court to conduct the Prosecution ably and efficiently and to secure conviction of the criminals to get them appropriately arranged in appropriate situation seek compensation for the victim of crime to balm their sprain reason out of crime.
- 4 To improve the quality of human resource, the department is arranging and providing necessary training to the Prosecutors as well as its officials and Lap tops equipped with software containing latest law on the subject are being provided to the majority of Prosecutors and being provided to the remaining Prosecutors in the phased manner.
- The District Attorneys being Member Secretary to reduce pendency litigation drive of stale cases are doing work to reduce the criminal litigation whereas Director of Prosecution as a Member of Department Level Monitoring Committee created under the ADRS and H.P.
