The contractual appointee will be paid fixed contractual amount of ₹ 15900/- per month. (Rupees Fifteen Thousand and Nine Hundred only), which shall be equal to minimum of he Pay Band + Grade Pay+ 75% of G.P of the post of Supervisor. The contract appointee will be entitled for increase in contractual amount @ 3% of the pay band +Grade Pay for further extended years and no other benefits such as senior/selection scales etc. shall be given. The contract will be extended/ renewed if work performance and conduct of the contract appointee is found satisfactory.

- The service of the contract appointee will be purely on temporary basis. The appointment is liable to be terminated in case the performance/conduct of the contract appointee is not found satisfactory.
