Before sending the ACR's all are requested to take due care about name of candidate, category, Date of Birth and Seniority as per Final Seniority List as it stood on 31.08.2022 to avoid future –representations. It also indicated that a person having a valid certificate of benchmark disability would be eligible for the benefit of reservation amongst the Medical Laboratory Technician Gr-II who possesses ten years regular service or regular combined with continuous adhoc service rendered, however, no benefit of reservation would be given on the basis of a temporary certificate of disability.
