OFFICE ORDER

On the recommendations of the Department Promotion Committee held on 30.11.2024 in pursuance to the Finance Department's letter No. FIN(PR)-B(7)59/2010 dated 9.8.2012, and further clarification vide Govt. letter No. Health-A-B(15)27/2011 dated 20.10.2015, Govt. No. Health-A-B(7)-2/2005/III dated 18.05.2022 and Govt. letter No. Health-A-B(7)3/2005-I dated 29.5.2017 four tier Pay Scales on completion of 4-9-14 years services is hereby granted to the Medical Officers, as per list attached as **Annexure-A-I, Annexure-A-II, Annexure-A-III** respectively on the following terms & Conditions.

(i) The clarification given vide HP Government letter No. Health-A-B(10)1/2009 dated 29.3.2017 may also be taken care of while fixing the pay in these cases.

(ii) The CMOs/Principals/Sr. Med.Suptd.to take further necessary action by fixing the pay of doctor concerned as per scale(s) so released. However, it may be ensured that the pay fixation is made in consultation with the Assistant Controller (F&A) posted in their offices for which they will be personally accountable for any lapse/wrong fixation.

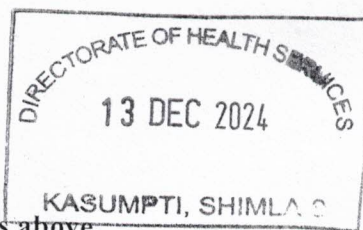
(iii) In case any of the doctors mentioned in the attached **Annexure-A-I, Annexure-A-II, Annexure-A-III** has/have availed EOL without medical grounds/ to pursue higher studies/ due to commutation or has some Dies Non service, their pay may not be fixed and such cases with full details be sent to this Department for clarification, if any.

(iv) The CMO/Principal will check the service records of doctors before fixing their pay.

(v) That there is no double drawl on account of arrears of four tier pay scale to the Doctors due to their transfer/deputation or PG course etc.

(vi) It may also be ensured that entries to this regard be also made in service books of Concerned M.O. accordingly.

These orders are subject to verification by the audit and in case any recovery is pointed out, the same shall be effected from the Doctor concerned from their salary or other dues.




