"OFFICE ORDER"

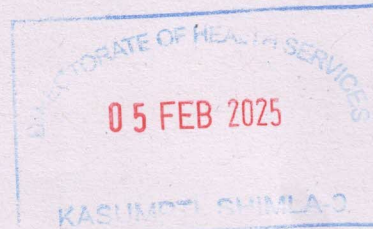

NOTE:- The concerned Head of the Institutions / DDO's are requested to relieve the officials within stipulated period and their relieving/joining may be intimated to this Directorate with due course of time, failing which defaulting officers shall be responsible for non-compliance to the orders.
