In pursuance to the decision contained in Govt. of H.P. Deptt. of personnel letter No. PER(AP)-C-B(2)-2/2015 dated 22-04-2016 and on the recommendation of the screening committee, the services of the following Staff Nurse who has been initially appointed Under RKS Contract and her services has been converted into Govt. contract after three years, is hereby regularized on the same post in the pay scale of ₹ 10300-34800+₹ 3200 Grade pay with immediate effect. After completion of two years continuous services she will be entitled to get the revised pay scale of ₹ 10300-34800+4600 Grade pay:-

The above appointment shall be subject to the following terms and conditions :-

1. The appointment/regularization is purely on temporary and liable to be terminated at any time by a month's notice from either side viz, the appointee or the appointing authority.
2. The appointment carries liabilities to serve anywhere in Himachal Pradesh.
3. The appointment is further subject to the production of following certificates/documents before joining the duty in the respect institution.
 - a. Certificate of Medical fitness issued by the Chief Medical Officer concerned/competent authority.
 - b. Certificate of Educational qualification i.e. Matriculation Certificate/Plus Two/Diploma in GNM duly recognized by the Central/State Govt. and duly registered with HP State Nursing Council Shimla.
 - c. Character certificate from the Magistrate First Class or any Gazetted Officer to whom the candidate known for the last five years.
 - d. Certificate of Bonafide Resident of Himachal Pradesh.
 - e. A certificate if he/she belongs to SC/ST/OBC/WFF/IRDP from the Magistrate First Class.
 - f. A declaration that candidate have not/shall not have more than one living husband/wife.
 - g. A declaration to the effect that if any of the information or documents submitted by him/her is found false, his/her services will be terminated without any further notice.
 - h. The appointee shall have to submit the nomination of Group Insurance Scheme, 1984 at the time of joining of duty.
 - i. That the appointment is subject to the verification of his/her character and antecedents.
 - j. No TA/DA will be allowed for joining the duty.
 - k. If the above terms and conditions are acceptable to him/her, he/she should report for duty at their present places of posting within fifteen days which the offer shall be treated as cancelled.
 - l. The appointee shall have to submit his/her assets and liability on the prescribed proforma.

Note :- The above mentioned Staff Nurse will submit her joining at her present place of posting on regularization.
