In pursuance to the policy formulated by the Government of H.P. The above appointment shall be subject to the following terms and conditions:-

1. The appointment/regularization is purely temporary and liable to be terminated at any time by serving one month notice from either side viz a viz the appointee or the appointing authority.
2. The appointment carries liability to serve in any part of H.P.
3. The appointment is further subject to the production of the following certificates/documents before joining the duty in the respective institution.
  - a) Certificate of Medical Fitness issued by the CMO/MS of the concerned District.
  - b). Certificate of Matriculation to proof of DOB/Educational Qualification (10+2)/proof of age thereof.
  - c). Character Certificate from the Magistrate 1st Class or any Gazetted Officer to whom the candidate is known for the last three years.
  - d). Certificate of Bonafide Resident of Himachal Pradesh.

- e). A Certificate if he/she belongs to SC/ST/OBC/WEF/IRDP/EX. Serviceman from the competent authority.
- f). A declaration that candidate have not/shall not have more than one living husband/wife.
- g). A declaration to the effect that if any of the information or documents submitted by him/her proved to be false his/her services will be terminated without any further notice.
- h). Appointment is subject to the verification of his/her Character Antecedent.
- i). No TA/DA will be allowed for joining the duty.

4. The regularization will be strictly on the basis of seniority subject to the condition that eligibility criteria etc. prescribed in the Recruitment and Promotion Rules for the post have been observed at the time of their initial recruitment on contract.

If the above terms and condition are acceptable to him/her, he/she should report for duty at their respective places of posting as shown above against their names within fifteen days failing which the offer shall be treated as cancelled, without further notice.
