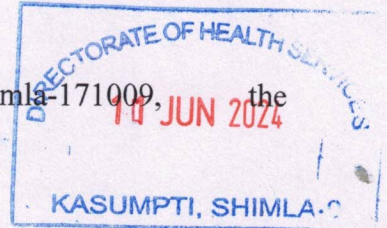



**Terms and Condition for Regularization is as under:-**

1. The post is temporary but likely to be continued. His /her regularization to the cadre is subject to review by the Government.
2. No TA/DA will be admissible for joining the service at his / her place of posting unless and otherwise admissible under rules.
3. The candidate will have to serve the Department anywhere in HP and he/she may also to serve in difficult area notified , for a minimum period of 3 years.
4. The candidate concerned shall have to produce the certificate of his/her being citizen of India.
5. The concerned candidate will have to take an oath of allegiance and faithfulness to the Constitution of India.
6. The Candidates' regularization /retention in service is subject to his/ her character and antecedents being found satisfactory through the concerned Head of the Institution within stipulated period of three months.
7. The concerned candidate shall have to produce a character certificate from a Tehsildar/ Naib Tehsildar.

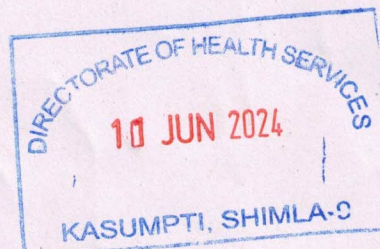
8. The concerned candidate will furnish a declaration to the effect that he/she is not a dismissed employee of any Govt. / Semi Govt. Department / Organization.
9. The concerned candidate will furnish a declaration to the effect that he / she has one living spouse.
10. The Candidate will have to give in writing, whether he / she was ever convicted by any criminal court or any departmental proceeding/ vigilance case is not pending against him/ her.
11. The candidate will have to submit category certificate to which he/ she belongs issued by the competent authority.
12. The candidate will have to produce the attested copies of Himachal Bonafide Certificate and certificate bearing date of birth at the time of joining.
13. The candidate will to submit a return of assets and liabilities as required under rule 18(1) of the CCS (Conduct) Rules 1964.
14. The candidate should have possess i.e. (i) Should be 10+2 in Science from a recognized Board of School Education, (ii) Degree or Diploma in Pharmacy from a recognized University or an Institution duly recognized by the Central/ State Government, the candidates who have done diploma in Pharmacy prior to 12.09.2001 and are matriculates shall not be rendered ineligible, (ii) must be registered with the Pharmacy council of the concerned State/ Central Government for the above qualification and attested copy of certificate be submitted in the Head of the concerned Institution.
15. Regularization of service can be terminated at any time by giving one month notice or by paying a sum equivalent to salary of a month or a sum equivalent, for a period by which the period of notice fall short or one month without assigning any reason or if any discrepancy comes to the notices at a later stage.
16. The candidate should be medically fit for the post against which he/ she is being considered for regularization obtaining the Medical fitness certificate of the candidate shall ensured in accordance with provision contained in FR 10 and SR4(1),4(2) and 4(3).


