Consequent upon their regularization no one is left to perform the duties of Safai Karamehari/Chowkidar.

As per instructions issued by the State Government from time to time part time workers are initially converted to whole time paid workers with same designation after completion of 10 years of continuous service as such on a specific cut off date. Further the incumbents who have completed 8 years of service as daily wager on a particular cut off date prescribed by the Government may be regularized on the same post on which he has completed prescribed length of service as daily wager.

Apart from other parameters prescribed therein, it was specifically made clear [vide Para-(1)] that fresh recruitments within Government for functional Department(s) will require prior concurrence of Finance Department and approval of the Cabinet will be mandatory, which implied that only newly created posts vis-à-vis the posts to be filled up by any mode of direct recruitment will need the prior approval of the Cabinet and there is no need to seek the prior approval of the Cabinet for filling up of posts the Government secondment or deployment basis within Department(s)/PSU(s) if there is a provision of secondment or deployment in their R & P Rules.

On the above subject, I am directed to intimate that as per present practice for release of funds under various Centrally Sponsored Scheme(s), cases for providing additionality against Central Share for which token provision exists in the budget are being received in Budget Section(s) of this Department. Once the additional funds are allowed by the Budget Section(s) of Finance Department to the respective Administrative Department(s), they move their proposals again to this Department for according expenditure sanction(s) which implies that they have to come up twice to Finance Department for clearance of a single proposal.

In order to avoid duplicacy/delay in incurring expenditure on such schemes vis-à-vis to simplify the procedural requirement(s) thereof, it has been decided that henceforth Administrative Department(s) would be competent to accord expenditure sanction(s) once the additional funds are provided by Budget Section(s) of Finance Department under any of the Central Sponsored Scheme, except for those component(s) of Centrally Sponsored Scheme(s) which involve creation/filling up of posts, purchase of vehicles/furniture items etc. on this account. Further, this is subject to compliance of rules/norms/guidelines framed for the Centrally Sponsored Scheme(s).

Similarly, for release of State Share under Centrally Sponsored Scheme(s) for which provision is made in the budget, the Administrative Department(s) move proposal(s) to Finance Department for according expenditure sanction(s). Henceforth, Administrative Department(s) would be competent to accord expenditure sanction(s) for State Share as well, at its own level only on receipt of matching Central Share, except for those proposal(s) involving creation/filling up of posts, purchase of vehicles/furniture items etc. on this account. Further, this is subject to compliance of rules/norms/guidelines framed for the Centrally Sponsored Scheme(s).
