अधिसूचना

हिमाचल प्रदेश की राज्यपाल, भारत के संविधान के अनुच्छेद 309 के परंतुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, हिमाचल प्रदेश राज्य में लागू फण्डामेंटल रूलज के रूल-56 का और संशोधन करने के लिए निम्नलिखित नियम बनाते हैं, अर्थात् :-

संक्षिप्त नाम और प्रारम्भ । 1. (1) इन नियमों का संक्षिप्त नाम फण्डामेंटल (हिमाचल प्रदेश) संशोधन नियम, 2016 है।

(2) ये नियम राजपत्र(ई-गजट), हिमाचल प्रदेश में प्रकाशन की तारीख से प्रवृत्त होंगे।

रूल 56 का संशोधन । 2. हिमाचल प्रदेश राज्य में लागू फण्डामेंटल रूलज के रूल-56 में, क्लॉज (जी) के पश्चात् निम्नलिखित क्लॉज (एच) जोड़ी जाएगी, अर्थात्:-

"(h) A General Duty Medical Officer under the Directorate of Health Services, Health and Family Welfare Department shall retire from service on the afternoon of the last day of the month in which he/she attains the age of 60 years:

Provided that a General Duty Medical Officer whose date of birth is the 1st day of month shall retire in the afternoon of last day of the preceding month on attaining the age of 60 years."

NOTIFICATION

In exercise of the powers conferred by proviso to Article 309 of the Constitution of India, the Governor, Himachal Pradesh, is pleased to make the following rules further to amend Rule 56 of the Fundamental Rules, in their application to the State of Himachal Pradesh, namely:-

Short title and commencement.

1. (1) These rules may be called the Fundamental (Himachal Pradesh) Amendment Rules, 2016.

(2) These rules shall come into force from the date of publication in the Rajpatra (e-Gazette) Himachal Pradesh.

Amendment of rule 56. 2.

In Rule 56 of the Fundamental Rules, in their application to the State of Himachal Pradesh, after clause (g) the following clause (h) shall be added, namely:-

“(h) A General Duty Medical Officer under the Directorate of Health Services, Health and Family Welfare Department shall retire from service on the afternoon of the last day of the month in which he/she attains the age of 60 years:

Provided that a General Duty Medical Officer whose date of birth is the 1st day of month shall retire in the afternoon of last day of the preceding month on attaining the age of 60 years.”
