- 4. The release of Grants-in-aid to the Government of Himachal Pradesh is subject to the following terms and conditions and the guidelines contained therein should be complied by the State Government.
 - a) The sanction of above mentioned amount will be governed by the provisions of the General Financial Rules, 2017 as amended from time-to-time.
 - b) The State Government will utilize the funds for the purpose for which it has been released. The State Government will furnish progress report indicating physical and financial achievement on quarterly basis till the coverage of all beneficiaries under the scheme and completion of the project. Besides, the State will also furnish utilization certificate in respect of the central grant released and utilized, failing which further release of central fund will not be considered.
 - c) The accounts regarding release of funds and their utilization shall be open to inspection by the Sanctioning Authority and Audit, both by the Comptroller & Auditor General of India and internal audit of the Principal Accounts Office of this Ministry.
 - d) The State Government has no unspent balance as due for rendition under this sub-component.
- 5. The Government of Himachal Pradesh will ensure transfer of benefit to beneficiaries directly to their accounts in electronic mode through DBT platform, and furnish the details of beneficiary name, Aadhaar number, mobile number, Bank account number to this Department.
