Sir,

I am directed to convey the sanction of the President of India to the release to the tune of **Rs.10.98 Crore (Rupees Ten Crore Ninty eight Lakhs only)** to the State of Himachal Pradesh, out of Central Road & Infrastructure Fund (CRIF) for the financial year 2022-23. With this release total fund released during year 2022-23 is **RS.10.98 Crore + Rs. 158.07 Crore release during 2022-23= RS.169.05 Crore**

2. These funds should be used for the projects sanctioned under CRIF as per CRIF rules and amendments made thereon.
3. For the funds to be utilized under the old on-going CRIF schemes, the State Govt. of Himachal Pradesh is requested to ensure the funding pattern laid down in the relevant sanction letters of the Ministry.
4. The State Govt. of Himachal Pradesh will be required to furnish the utilization certificate in accordance with Form-I along with quarterly progress report and Expenditure report as per Form-II of the Ministry's aforesaid guidelines dated 31.01.2020.
5. Principal CCA's Office is authorized to issue necessary credit advice for this payment.
6. Utilization Certificate has been received, checked and found in order and kept in record.
7. The State Govt. of Himachal Pradesh is also required to furnish the completion reports/certificate duly verified by the Audit as and when the work is completed.
8. "The expenditure is debitable under the Major Head-3601-Grants-in-aid to State Governments (Major head); 08- other transfer/Grants to State (Sub-Major Head);
08.108 - Road; 01.00.35 - Grants for Creation of Capital Assets corresponding to Demand No. 86 of the Ministry of Road Transport & Highways for the year 2022-23".
