I am directed to refer to the subject cited above and to say that the directions were issued by Hon'ble High Court of Himachal Pradesh in various Civil Writ Petitions for consideration of conferment of work charge status on the writpetitioners/ respondents in terms of the policy instructions dated 3.4.2000 read with policy instructions dated 6.5.2000. These orders were contested by the State Government by way of filing an SLP in Hon'ble Supreme Court of India and the Hon'ble Supreme Court has granted an interim stay of the impugned judgements/ orders of Hon'ble High Court of Himachal Pradesh on 01.08.2011 in CWP tilted as State of HP & Ors Versus Mangal Sain & Ors. etc. (copy enclosed).

- 2. I am further directed to say that in view of the interim stay granted by Apex Court, the decision of Hon'ble High Court, if any, in respect of conferment of work-charge status may be contested on the basis of the strength of this judgement by filing an LPA or the Review Petition, as the case may be, and also the reply to a CWP on this issue may be filed on the basis of these orders of Apex court, it being the sub-judice matter before the Hon'ble Supreme Court or India.
