It has been, therefore, decided that all the departments should complete their purchases/annual procurements by 31.01.2010 for the year 2009-2010, after completing all codal formalities. This date of 31st January may be considered as the standing cut-off date by the Departments for purchases/procurements to be made in subsequent years, also.
