Fixation of pay on promotion in identical pay scales.

The undersigned is directed to say that vide 0.M. of even number dated the 5th August, 1959 orders were issued allowing benefit of FR-22(C) on promotion in identical pay scales which were later withdrawn vide 0.M. of similar number dated 29-8-1990.

- 2. On reconsideration of the matter and in relaxation of the provision to the contrary, if any, under the Fundamental Rules and the H.F.Civil Services(Revised Pay)Rules, 1988, the Governor, Himachal Pradesh is pleased to order to restore decision as contained in 0.M. dated 5-8-1989 referred to above with the condition that where the event of promotion after 1-1-1986 till the date of revision of Pay Scales of these posts has taken place more than once, the benefit of F.R.22(C) will be available only once.
- 3. It is further advised that all departments should immediately re-frame the R&F Rules in conformity with Pay Revision orders.
