3. The release of grants-in-aid is subject to the following conditions:

- i. States are required to complete construction by 31st March, 2018 and send physical progress report and utilisation certificate with photographs of all constructed toilets in AWCs by 30th April, 2018;
- ii. In the above release, the Centre and State contribution have been calculated on 90:10 ratio. The States are required to contribute their share of 10% for construction of toilets and providing drinking water facilities in Anganwadi Centres;
- iii. The Toilets should be child friendly and constructed as per guidelines of Swachchhata Action Plan;
- iv. Additional funds for construction of Toilets, if required, may be sourced from Panchayati Raj Institutions and MGNREGS.
- 4. This grant-in-aid is towards the non-recurring expenditure for the ICDS Programme. The payment is provisional and is subject to final adjustment in the light of the audited figures of actual expenditure for the year as a whole vide Ministry of Finance letter No. 2(19)-P.II/60 dated 9.10.1964, as amended from time to time, addressed to all State Governments etc.
- 5. The Grant-in-aid is subject to the condition that, when the Scheme is closed or abandoned, the receipt from the disposal of assets, built out of the whole or a portion of the grant now sanctioned will be shared between the Governments in proportion with their respective shares in the capital cost to assets.
- 6. The expenditure is debitable to the Major Head "3601" Grants-in-aid to State Governments (Major Head) in Demand No. 99 Ministry of Women & Child Development; 06-Centrally Sponsored Schemes (Sub Major Head) -, 06.101-Central Assistance / Share-47- Integrated Child Development Services (ICDS), 01- Anganwadi Services-47.01.35 Grants for Creation of Capital Assets during 2017-2018 (Plan).
- 7. The amount of Grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Women and Child Development, Shastri Bhavan, New Delhi. The payment of these States would be arranged through the Reserve Bank of India, Nagpur. The State Accountant General will send intimation regarding receipt of Grant-in-aid to the Principal Pay & Accounts Office, Ministry of Women and Child Development, Shastri Bhavan, New Delhi.
- 8. The State Govt. may ensure that the funds released are utilised within the current financial year for construction of Toilets and providing Drinking Water facilities at AWCs.
- 9. The pattern of grants has already been approved by the Ministry of Finance. This sanction is being issued in conformity with the rules and principles of the scheme approved by the Ministry of Finance.
