Sub: Raising of 5th IR Bn. by Government of Himachal Pradesh – release of fund – Grants-in-aid.

Sir,

I am directed to refer to State Government of Himachal Pradesh letter No. Home-(A)B(1)/2008-1 dated 17 October 2017 on the above subject and to say that this Ministry vide letter No.16011/6/2006-PF.IV (xiv) dated 31 March 2008 had conveyed sanction of the President for raising of 5th IR Bn by the Government of Himachal Pradesh with stipulation that Central Govt. shall reimburse Rs.12.75 crore (75% of the standard cost of raising i.e.Rs.17.00 crore) and besides, 50% of the capital cost (excluding cost of land) subject to a maximum of Rs.15.00 crore on submission of requisite details regarding expenditure incurred on infrastructure. So far. Rs. 12.75 crore as standard raising cost and Rs. 8.465 crore as infrastructure cost has been reimbursed towards this IR Bn. Balance Rs.6.535 crore is yet to be reimbursed. Now the Govt. of Himachal Pradesh has furnished claims for Rs.3.2277 crore which incurred on infrastructure for this IR Bn. and requested for release of fund.
