In continuation of sanction order of even no. dated 30.03.2018 for releasing of Rs. 16 crore as part of project fund of first year instalment to State Government of Himachal Pradesh for development of Shimla as Smart City, I am directed to convey the sanction of the Competent Authority for the release of Rs 34,00,00,000/- (Rupees Thirty four crores only) as part of project funds for 1st year instalment to State Government of Himachal Pradesh for development of Shimla as Smart City in terms of Para 12.2 of SCM Guidelines.

- 2. The aforesaid sanction is subject to the following conditions:

 - iv) The money will be utilized strictly in accordance with the Mission Guidelines and for the purpose for which it has been sanctioned.
 - v) This fund will not be utilized/used for setting up the SPV or for their internal uses.
 - vi) The SPV through ULB/State Government will furnish utilization certificate in respect of total funds of Rs. 34 crore and funds released earlier at an early date in the prescribed Performa as provided in the SCM Guidelines.
- No Utilization Certificate is pending for any previous release. 3.
- The expenditure involved will be debited to the Major Head 3601-Grant-in-aid to State Govts., 06-Centrally Sponsored Schemes, 101-Central Assistance/Share., 23-Mission for 100 Smart Cities, 23.00.35- Grants for creation of capital assets under Demand No. 56-Ministry of Housing and Urban Affairs of the year 2018-19.
- The amount of Rs 34,00,00,000/-(Rupees Thirty four crores only) may be transferred to State Government of Himachal Pradesh through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide OM No. F-II (45/76/SC) dated 22.02.1977.
