  - The Central assistance would be subject to adherence to the provision of the Food Security (Assistance to State Governments) Rules, 2015, dated 17.08.2015.
  - b. For FPS dealers' margin, the utilization of fund shall be restricted to payment of basic margin only and not for additional margin for sale through point of sale deveice, which shall be governed by provisions under sub-rule (3) to (5) of Rule 7 of the Food Security (Assistance to State Governments) Rules, 2015.
  - c. The amount shall be spent for the purpose for which it is being sanctioned. Any part of the sanctioned amount which is in excess or remains unutilized shall be adjusted against subsequent release.
  - d. The State Government shall submit Utilization Certificate in prescribed proforma to the Central Government as provided under General Financial Rules, 2005 and Food Security (Assistance to State Governments) Rules, 2015.
