The State shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due. Provisional Utilization Certificate for the FY 2017-18 has been received.
- 6. Grant in-aid shall be used for the purpose for which sanction is given. An annual utilization certificate (in Form **GFR 12C**) shall be utilized for the purpose for which it was sanctioned.
- 7. The sanction order is being issued in accordance with Rules 228 to 245 of General Financial Rules, 2017.
- 8. The expenditure involved is recurring and will be met from the funds provided under Major Head 3601- Grants-in-aid to State Governments (Major Head); 06 Centrally Sponsored Schemes (Sub-Major Head); 789 Special Component Plan for Scheduled Castes (Minor Head); 04- National Rural Health Mission 04.09- Other Health System for activities covered under NRHM (support from NIF); 04.09.35- Grants for creation of Capital Assets in Demand No. 42 Health & Family Welfare during 2018-19.
