- 2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22nd January, 1977 and is to be paid in Cash.
- 3. The States shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, GoI.
- 4. The States shall ensure that 40% of its share based on release of funds by GOI is credited to appropriate accounts.
- 5. The States shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.
- 6. Grant in-Aid shall be used for the purpose for which sanction is given. An annual utilization certificate (in Form **GFR 12C**) shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.
- 7. The Provisional Utilization Certificates towards releases made during the year 2017-18 from the above States have been received.

- 8. The sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rules, 2017.
- 9. The expenditure covered by this sanction will be met from the funds provided under Major Head 3601- Grants-in-aid to State Governments (Major Head); 06 Centrally Sponsored Schemes (Sub-Major Head); 789 Scheduled Castes Sub Plan (Minor Head); 04- Naional Rural Health Mission; 04.03-Flexible Pool for Communicable Diseases; .04.03.31- Grants-in-aid General in Demand No.42 Health & Family Welfare during 2018-19.
