- 3. The States shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, GoI.
- 4. The States shall ensure that 40%/10% of its share based on release of funds by GOI is credited to appropriate accounts.
- 5. The States shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due. Provisional Utilization Certificate for the FY 2017-18 has been received.
- 6. Grant in-aid shall be used for the purpose for which sanction is given. An annual utilization certificate (in Form GFR 12C) shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.
- 7. The sanction order is being issued in accordance with Rules 228 to 245 of General Financial Rules, 2017.
- 8. The expenditure involved is recurring and will be met from the funds provided under Major Head 3601- Grants-in-aid to States Governments (Major Head); 06 Centrally Sponsored Schemes (Sub-Major Head); 796 Tribal Area Sub Plan (Minor Head); 04- National Rural Health Mission 04.09- Other Health System for activities covered under NRHM (support from NIF); 04.09.31- Grants-in-aid General in Demand No.42 Health & Family Welfare during 2018-19.
