- The allocation for the State of Himachal Pradesh for the year 2018-19 is Rs 477.89 lakh. Funds to be released as Central Share is Rs 169.44 lakh (General: Rs 1,24,03,010/-, SCSP: Rs 38,12,400/- and TSP: Rs 7,28,590/-), after deduction of Rs 251.97 lakh unspent balance available for previous releases under all categories (General, SCSP and TSP) as on 31.03.2018.
- Release of the above grant is subject to the following conditions: 3.
  - The grant will be utilized in accordance with the approved guidelines for the (i) implementation of the Scheme.
  - Sharing pattern between the Central Government and the State (ii) Government is 90:10, in terms of the Ministry's OM letter No. G-24011/4/2015-UPA FTS: 13027 dated 2nd February, 2016.
  - The funds will be utilized for the purpose for which they are sanctioned. (iii) Otherwise funds will have to be refunded along with interest as per the provisions of GFR-2017.
  - Separate Utilization Certificates should be submitted for each sanction, (iv) for speedy reconciliation of the accounts.
  - Progress of the scheme will be updated on DAY-NULM MIS portal on time. (v)
