Subject: - Administrative Approval and expenditure Sanction for release of grants of Rs.16.462 lakh during 2016-17 to the Government of Himachal Pradesh for Propagation of Artificial Insemination in Goats in Himachal Pradesh by CSK Himachal Pradesh Krishi Vishvavidyalaya, Palampur, Himachal Pradesh during 2016-17.

I am directed to refer to the Department of Animal Husbandry, Govt. of Himachal Pradesh letter No. AHY-C(10)-1/2012-I dated 08.08.2016 on the subject mentioned above and to convey the administrative approval and expenditure sanction toward release of **second instalment** of Grants in-aid of Rs.16.462 lakhs (Rupees Sixteen Lakhs Fourty Six Thousand and Two Hundred only) to Government of Himachal Pradesh during 2016-17 for Propagation of Artificial Insemination in Goats in Himachal Pradesh by CSK Himachal Pradesh Krishi Vishvavidyalaya, Palampur, Himachal Pradesh during 2016-17.

2. Further release may be effected upon receipt of physical /financial progress and utilization certificate.

3. Total project cost will be reviewed in the Department once the State declares the University as State Implementing Agency for implementation of the scheme.

3. The expenditure involved is debitable to the following head of account:

Demand No-3- Animal Husbandry, Dairying & Fisheries
3601-Grant-in-aid to State Governments. (Major Head)
02-Grants for State Plan Schemes (Submajor Head)
583 Animal Husbandry – Fodder and Feed Development (Minor Head)
02- White Revolution-Rashtriya Pasudhan Vikas Yojana
02 – National Livestock Mission
020231-Grants-in-aid –General

4. The sum of Rs.16.462 lakhs (Rupees Sixteen Lakhs Fourty Six Thousand and Two Hundred only) is being released in accordance with the approved pattern of funding of the project.

5. The Grants-in-aid is sanctioned on the condition that this will be utilized for the specific scheme and the estimates of the expenditure is treated as maximum and effort is made to effect

as much economy as possible without deterioration of the scheme and also the expenditure is incurred within the ceiling approved by the Government of India under the scheme.

6. As requested by the CSK Himachal Pradesh Krishi Vishvavidhalaya, Palampur, Himachal Pradesh vide letter No QSD/IVCC/DGCN/COVAS/4325 dated 04.05.2016 and duly forwarded by the Department of Animal Husbandry, Govt. of Himachal Pradesh the university is hereby permitted to purchase some additional items, namely an air conditioner, laminar flow and refrigerator, for which no additional fund would be required and the purchase would be made from the 2nd year grant only.

7. CSK Himachal Pradesh Krishi Vishvavidhalaya, Palampur shall maintain separate accounts for the expenditure incurred and submit a statement of account to the Government of Himachal Pradesh and Department of Animal Husbandry, Dairying and Fisheries, Ministry of Agriculture, Government of India in due course.

7. The Accounts regarding release of funds to the State Government of Himachal Pradesh and utilization of these funds for Propagation of Artificial Insemination in Goats in Himachal Pradesh by CSK Himachal Pradesh Krishi Vishvavidhalaya, Palampur, Himachal Pradesh shall be opened to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India and Internal Audit of the Principal Accounts Office of the Ministry.

8. The assets referred to above shall not without the prior approval of the Government of India be disposed of encumbered or utilized for the purpose other than those for which the funds are being released.

9. The payment of amount is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance's letter No. 2(19)P-11-60 dated 9th October, 1984. The actual figures of expenditure duly audited by the Accountant General may, therefore, kindly be furnished to this Ministry as early as possible.

10. Progress of utilization of grants will be reported in **GFR-19A** format quarterly to Government of Himachal Pradesh and Government of India.
