I am directed to convey the Expenditure Sanction of the President of India for the payment of Grants-in-aid Rs.5,85,000/-(Rupees Five Lakh Eighty Five Thousand Only) as second instalment to Government of Himachal Pradesh, Department of Animal Husbandry under National Livestock Mission Scheme for implementation of various components as detailed in Annexure.

- 2. The programme is to be implemented on the following terms and conditions.
- (a) The Central Grant is sanctioned on the condition that this will be utilized for specific purpose and places/projects as per the proposal submitted by the State Government vide their letter No.AHY-H(II)-F-7-27/76-Vol-3 dated 20th August 2018 from Director, Animal Husbandry Himachal Pradesh, Shimla-5.
- (b) The Government of Himachal Pradesh would arrange matching share for each component- as mentioned in the annexure (as per the guidelines of the scheme).
- (c) The estimated expenditure is to be treated as maximum and all efforts will be made to effect as much economy as possible without deterioration of the scheme and also that the expenditure incurred within the ceiling approved by the Government of India.
- (d) The State Government of Himachal Pradesh will maintain proper account of expenditure incurred and submit the statement of the audited accounts to the Government of India in due course.
- (e) The account of grant shall be opened to check test by the Comptroller and Auditor General of India at his discretion.
- (f) In terms of relevant rule of General Financial Rules, 2017, the account of Grantee Institutions or organizations shall be open to inspections by the sanctioning authority and audit both by the Controller and Auditor General of India and under the provision of CAG (DPC), 1971 and under audit by the Principal Accounts Office of the Department, whenever the Institution/Organization call to do so.
- (g) The State Government/Grantee organization shall submit an audited certificate of actually utilization grants in-aid sanctioned in prescribed Proforma GFR,2017 specifying report on targets and achievements cum performance report to the sanctioning Authority.
- (h) The proposal will be implemented by the State Government strictly as per the guidelines contained in the scheme, conditions laid down in Administrative Approval issued by this department's vide letter No.99-6/2018/NLM/Admn. Approval dated 02/05/2018 such as women beneficiaries, etc. and as per the proposal approved by this Department.

(i) The purchase of items may be done following General Financial Rules 2017 (GFR)/Store purchase rules.

(i) No double benefit be provided to a farmer under the components.

3. The expenditure of Rs.5,85,000/- shown in para 1 above, may be debited to the following head of account:

- 4. The State Government will utilize the fund for the scheme for which this amount is released and submit the utilization certificate, statement of expenditure and physical progress in stipulated format through Administrative Head to this Ministry in due course as per the guidelines for release of balance funds.
- 5. As advised by IFD of this Department, State Government of Himachal Pradesh is requested to submit pending UCs by 31.03.2019.
- 6. The States & UTs will mandatorily source germplasm/ animals/ Day Old Checks/ Hatching eggs, etc from Government Organizations including ICAR and Universities as mentioned in the NLM Guidelines. If the Government Organizations including ICAR and Universities are unable to supply then only it should be sourced from Private Organizations strictly following GFRs.
- 7. This issues under the delegated powers and with the concurrence of Integrated Finance Division of this Ministry vide their Dy. No.4682/AS&FA dated 13/03/2019.
- 8. This has been noted as per GFR Rule 212 (4)(b) at S.No.79 of Page No.22 of the Register of Grants under National Livestock Mission for 2018-19.
- 9. The further use of Grants-in-Aid being released by this sanction Order is to be done through EAT module of PFMS. The Utilization Certificate not supported by the EAT module data is likely to be rejected and expenditure is not to be treated as regular. The agency would be forced to refund the amount received as the expenditure not appearing in EAT module data is not to be taken as expenditure incurred in accordance with the terms and conditions of the sanction Order.
