Subject: Release of funds to State Governments for procurement/replacement of Growth Monitoring Devices for Anganwadi Centres under Poshan Abhiyaan in Financial year 2022-23.

Sir,

I am directed to convey the sanction of the President to the payment of **Rs. 1110.02 lakhs (Rupees One Thousand One Hundred and Ten Lakhs and Two Thousand only)** to following 02 States to the extent of amount indicated against each as grants-in-aid towards procurement/replacement of Growth Monitoring Devices for Anganwadi Centres under Poshan Abhiyaan in Financial year 2022-23: -

2. The State Government will furnish Utilization Certificate in respect of the grants-in-aid released as per the provisions contained in GFR, 2017. Further, the State Government will maintain separate records of expenditure incurred for implementation of POSHAN Abhiyaan and furnish separate Statement of Expenditure and Utilization Certificate along with Physical Progress Report every quarter. The information on expenditure for the period 1st April to 30th June must be furnished by 15th July, for the period from 1st July to 30th September by 15th October, from the period 1st October to 31st December by 15th January and from 1st January to 31st March by 15th April to enable the Ministry to work out the entitlement of Central Assistance of each State Government/UT Administration.

3. The payment is provisional and is subject to final adjustment in the light of audited figures of actual expenditure for the year as a whole.

4. As per rule 236(1), the accounts of all Grantee Institutions or Organisations shall be opened to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution of Organisation is called upon to do so and a provision to this effect should invariably be incorporated in all orders sanctioning Grants-in-aid.

5. POSHAN Abhiyaan under Mission Saksham Anganwadi and Poshan 2.0 is a Centrally Sponsored Scheme and the Centre and State/UTs both have contributions.

Government budgetary support would be 60:40 between Centre and States/UTs with legislature, 90:10 for NER and 3 Himalayan States (Uttarakhand, Jammu & Kashmir and Himachal Pradesh) and 100% for UTs without legislature.

6. Of the total funds being released to a particular State is being released as per applicable cost sharing ratio between the Centre and the States & UTs as mentioned in para 5 above. The sanction of funds is subject to the following conditions:

- i. The amount of grant will have to be utilized for all the components under the Scheme as per the schematic norms;
- ii. The States/UTs shall also be required to contribute adequate amount for implementation of the Poshan Abhiyaan;
- iii. All the devices shall be procured through GeM, the expenditure for procuring the devices by the States/UTs shall be done as per schematic norms of Mission Saksham Anganwadi and Poshan 2.0 and expenditure on other activities to be done in accordance with the prescribed norms.

7. The expenditure is debit to **Major Headn '3601'-Grants-in-aid to State Governments; 06-Centrally Sponsored Schemes (Sub Major Head); 06.101-GIA General; 84-Saksham Anganwadi and POSHAN 2.0; 00-Anganwadi Services (POSHAN Abhiyaan); 84.00.31-GIA General Demand No. 101 of the Ministry of Women & Child Development for the year 2022-23 (Plan).**

8. The amount of grant-in-aid finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Women & Child Development, Shastri Bhawan, New Delhi. The Payment of the State would be arranged through the Reserve Bank of India, Nagpur. The State Accountant General will send intimation regarding receipt of grant-in-aid to the Principal Pay & Account Office, Ministry of Women & Child Development, Shastri Bhawan, New Delhi.

9. The pattern of grants has already been approved by the Ministry of Finance. This sanction is being issued in conformity with the rules and principles of the scheme approved by the Ministry of Finance.
