Sub:- Release of Grants to Himachal Pradesh as final installment for 1 New Professional College and Infrastructure Grants to 1 University under Rashtriya Uchchatar Shiksha Abhiyan (RUSA).

Sir.

I am directed to refer to the approval of the competent authority to release an amount of Rs.4,14,00,000/- (Rupees Four Crore Fourteen Lakh Only) as final installment for 1 New Professional College and Infrastructure Grants to 1 University at the centre : state share of 90:10 to be incurred to the State Government of Himachal Pradesh under Rashtriya Uchchatar Shiksha Abhiyan (RUSA). Under the initiative under reference, the Central Government shall provide assistance to the State Governments for various components, which are mentioned as per the guidelines under RUSA.

- Under RUSA, the Central Government shall provide assistance to the extent of 90% to special category states (NER, J&K, Uttarakhand and Himachal Pradesh). The fund being released are final installment for 1 New Professional College is Rs.2,34,00,000/- and Infrastructure Grants to 1 University is Rs.1,80,00,000/ at the central: state share of 90:10 to be incurred to the State Government of Himachal Pradesh under Rashtriya Uchchatar Shiksha Abhiyan (RUSA). The subsequent releases will be dependent on the submission of Utilisation Certificate for the 75% utilization of the grants released.
- Subject to approval of the competent authority and fulfillment of all conditions as per RUSA norms, MHRD shall release Rs.4,14,00,000/- (Rupees Four Crore Fourteen Lakh Only) of the allocation as the final installment. Further installments of the allocation shall be released by the Ministry only after the State Government concerned releases of its committed share towards non-recurring expenditure and recurring grants, besides submission of the Utilisation Certificate by the State in respect of the installment of the grant released.
- The sanction is issued in exercise of the powers delegated to Ministries under DFPR, 1978, as amended from time to time. Above grants are being released in accordance with the pattern of Assistance approved by the Ministry of Finance, Government of India. It is also certified that this Sanction is being issued in conformity with the rules and principles of the scheme.

The State will then transfer these amounts along with its matching grant to the RUSA bank account of State Higher Education Council (SHEC).
- The grant-in-aid is subject to adjustment on the basis of audited statement of accounts of Himachal Pradesh. Further, the accounts of Himachal Pradesh SHEC in so far as it relates to grants-in-aid will be open to inspection by the sanctioning authority and audit both; by the Comptroller & Auditor General of India or by any other designated by him and Internal audit by the Principal Accounts Office of the Ministry of Human Resource Development, Department of Higher Education, whenever it is called upon to do so.
- The amount is debitable to the following three Heads of Demand No.58-Department of Higher Education:
